Step Five Essay: Admitted to God, to ourselves, and to another human being the exact nature of our wrongs.

One of the lies that I used to tell myself is that "I'm different." I used to think that I'm not like the rest of all the other alcoholics in A.A. That created all kinds of problems for myself. I was lonely, resentful, filled with self-pity, and suffered from all sorts of rationalizations. When I was sick of my life, I got a sponsor. My sponsor asked me if I was willing to go to any lengths to gain victory over alcohol. After assuring him that I was, he told me to review the 12 Steps because those were some of the lengths he was referring to. We then started working through the steps, following the instructions in the Big Book.

When it came to my 4th Step, I felt hesitant. My alcoholic thinking had already anticipated both the 5th Step and the 9th Step, and I certainly didn't want to reveal some of my deeper secrets. However, in reading both the Alcoholics Anonymous and 12 Steps & 12 Traditions, I found specific warnings that if I skimped on the 5th Step, I might not overcome drinking.* As well, both books warned that my ego reduction would be mostly theoretical until I cleaned house and became entirely honest with another person. The Big Book also says, "We must be entirely honest with somebody if we expect to live long or happily in this world" (p.74). So I firmed my resolve to be thorough and honest. I knew that I was only as sick as my secrets. I made an appointment with my sponsor and prepared for a long talk.

In going into my 5th Step, I was nervous. I had brought my 4th Step. I tried to tell my sponsor that it wasn't neat enough — maybe I should type it up. He asked me if it was an honest appraisal: perfection wasn't the goal, but that it was to be fearless and thorough. To alleviate my fears, we began by praying and inviting our Higher Power into our conversation.

We talked about things that were on my 4th Step, and we shared stories that were similar. I talked about my character defects, how they affected me, and what my mistakes were. No part of my life was spared. Resentments. fears, and even my sex conduct were all disclosed. We discussed my part of each situation. I began to see how my character defects were holding me back in life. I was using dishonesty and self-seeking to avoid responsibility and keep others distanced from me. I was using resentments as justifications to judge others, feel self-pity, and justify my harms to others. I used fear to justify nearly all my character flaws and attempts to control my life and others. Drinking was just a symptom of all my problems.

Just as I had thought that my drinking mostly harmed myself. I thought that my character defects were really only harming myself. Now, I could see exactly where I had been selfish, and how my shortcomings were affecting my loved ones, friends, and coworkers. At one point, I felt ashamed; but by being honest with my sponsor, I felt a burden being lightened. My sponsor told me "you're not alone." He assured me that I didn't have to live like this anymore. I felt free for the first time in my sobriety. The loneliness I felt had disappeared. He told me that my 5th Step was really not very different at all from his. So, I wasn't different, after all! I was just like all the other people in A.A. There was a feeling of belonging that brought a new hope.

We ended our talk with prayer, thanking God for letting us get to know Him and each other better. Afterwards, I spent an hour quietly reflecting on things. For that hour, I was at complete peace. I felt I could look others in the eye and walk upright in this world. My mind was calm and clear, and my heart was light. I felt humility, without humiliation. Afterwards, I called my sponsor. We reviewed the previous steps. I was sure we were ready to keep going. A thorough 5th Step prepared me well for Step 6, since I could see the true cost of all my defects of character. I could see how they shut me off from the "sunlight of the spirit," and how they affected all those around me.

Since then, I have heard many 5th Steps. Each time, we are swapping stories, and each time we find that there is hope. The 5th Step helps me become more honest, open-minded, and willing. In hearing each other's stories, we graduate from being in the spirit of fellowship to the Fellowship of the Spirit. Each time I find that we are not alone, I am not as unique and disconnected from others, and that we all live with a common spiritual solution.

Message from the Manager: GSO Sets A Great Example of How We Help!!

Last month we received a call from a man whose brother needed a Twelfth Step call in his native language: Vietnamese. So, we checked our Twelfth Step list — no Vietnamese speakers. We called the Minneapolis Intergroup, and they didn't have anyone. Then we tried Milwaukee, Chicago, LA, New York, Mississippi and Alabama. Finally, someone suggested we talk to the General Service Office in New York — they might have dealt with this before, and might have an idea.

By this time it was 4:15 pm central time on a Friday, but I thought I'd call anyway in case there was a quick answer. Two staff members at GSO got involved, and they called AA contacts all over the country to find a way to help our guy. They found out that there was a Service Conference going on in the Northwest, and arranged for an announcement to be made. They called me back after 5pm our time — after 6pm in New York — to tell me what they had done and what else I might try in the meantime.

Early the next week, the newcomer showed up in the Intergroup office looking for a meeting directory. He'd already received a Twelfth Step call in Vietnamese from an AA member in Oregon, and someone had already shipped him a Vietnamese Big Book! I was amazed at the power of our fellowship, and how quickly AA responded to this seemingly difficult situation!

The staff at our General Service Office—whom we support with our Seventh Tradition contributions—set a great example. They show just how we ought to act towards the newcomer, and they take our Declaration of Responsibility very seriously : "When anyone, anywhere, reaches out for help, I want the hand of A.A. always to be there. And for that: I am responsible."


