



Step Six: Were entirely ready to have God remove all these defects of character.

#### The Forgotten Steps

After being in-and-out of meetings for almost a decade, I was finally separated from alcohol in the spring of 1990. I was attending a fair amount of meetings at the time. I had a home group. I had a sponsor. And I attended approximately 5 meetings a week. At different meetings I heard different ideas about how to approach Step Six. One of the things I heard at the time was "The Forgotten Steps" - Steps 6 and 7.

I had come to understand in a short period of time that the reason Steps 6 and & 7 were referred to as "the Forgotten Steps," is because people would talk about them in meetings, and then after the meeting they would not think about them again or consider working on their defects of character or shortcomings.

I was told to take my problems to my sponsor in my solutions to my meetings. It did not seem like much of a solution, if I was not taking action with the Steps when I was in-between meetings. So the next question would be, "What is the action we are taking with Step 6?" Part of the action entails working Steps 1 through 5 thoroughly before getting to Step 6. And I believe that working Step 6 means that I am preparing for Step 7.

Step Six: "Were entirely ready to have God remove all these defects of character." After I finished my first 5th Step, I was entirely ready to have all my defects of character removed. I had been beaten and battered spiritually and desperately wanted change in my life. I was unaware that God was the one that was going to remove them. So, as much as I wanted to change, I was still running in to myself. What I seem to be unaware of is the fact that it takes more action than just working the first five Steps of Alcoholics Anonymous.

My defects of character seem to be as outrageous as ever early in recovery; my selfishness, my self-centeredness, and my egotism, for example. Along with many other defects of character, were frequently dominating my life. I was still a living example of "self will run riot."

So what was the action I actually needed to take? I know that Steps 6 and 7 are not synonymous. And yet I also believe that they work very closely together. Step 7, "Humbly asked him to remove our shortcomings, is where I ask the Creator for help.

Therefore when approaching Step 6, in become entirely ready, means for me that I need to act as if my defects of character and shortcomings are gone. What I have found is that when I act as if the defects of character are gone and also prepare to ask that they be removed that my entire life is different, because at that moment I do not suffer from a defect of character.

My belief is that action will change my life. My defects of character tore apart my selfesteem and affected the way that I feel about myself. When I begin to take action, my thinking changes, and when my thinking changes how I feel changes.

Step Six: "Were entirely ready to have God remove all these defects of character." I must act as if a defect of character does not exist at this moment. I will not be selfish right now. And then promptly move on to Step 7.

# Tradition Six: An AA group ought never endorse, finance or lend the AA name to any related facility or outside enterprise, lest problems of money, property and prestige divert us from our primary purpose.

Whenever I consider the 6<sup>th</sup> Tradition of Alcoholics Anonymous, what tends to stick out to me is the phrase, "money, property and prestige." My thought, "How can there be anything Spiritual in all of those things for **ME**?" It seems so selfish. It seems our founders thought the same. If you look up the long form, the first line says, "Problems of money, property, and authority may easily divert us from our **primary spiritual aim**."

I was in an AA meeting once and a woman in the room said something very profound that resonated with me, but I don't remind myself of it near enough, "There are just two states of being ego or Spiritual—and you can't be in both at the same time." It's true. I'm either thinking of me and the things I believe I deserve, or I am centered with God thinking of others. These two states of being are mutually exclusive. I simply am incapable of doing both at the same time.

I'll give you an example to illustrate—in fact, two. I'm in the market to buy a new house. Originally, I'd planned to just get myself a small single-family home, but lately I've been considering duplexes or other forms of rental property. While looking at some listings, a thought occurred to me, "It would be nice to offer affordable rent to those early in recovery just getting started again." Within seconds, another helpful thought, "Yes, maybe I could furnish them for those that don't have many items yet."

Whenever this sort of thing happens to me, I figure its God. Heck, left to my own will, I'm selfish. I'm not going to just randomly think to sacrifice and share with another person. While all settled into these good and Spiritual thoughts to help others, in pops another thought, "Yeah, but I could be sacrificing a lot of rental income on that plan." Then along comes, "What if they trash the place? Start using? Don't pay rent? What if I am inconvenienced or hurt by another?" Just like that, selfishness and fear jump in, bringing me back to ego, attempting to thwart a helpful plan.

I have no idea what God has in store for me. Looking for a house and my upcoming move has been an exercise in "turning it over". I want the plan. I desire the destination, yet I must leave that in God's hands because I do not know where this adventure will bring me. Maybe God will provide the right rental property to help others. Or, maybe, that's not the plan. I must stay centered in the Spiritual principles of this program to ultimately find God's will for my life.

Just consider AA's co-founder, Bill W. By every account, an industrious and intelligent man, yet by the end of his life, he had not created the riches he'd originally desired. Many times, Bill and Lois stayed with friends, living off meager wages. Bill was focused on helping others. His passion was to save us alcoholics and while I imagine he had plenty of distractions from money, property and prestige (and he did—they are noted in several forms of AA literature) we should all be grateful it didn't did not divert him from the primary spiritual aim. Just as the Spiritual steps in the program are essential for wholesome individual recovery, the Spiritual basis of the traditions is designed to keep AA healthy and thriving as well.







## Trustee Orientation Preparation for Service

When I rotated onto the General Service Board upon election as the West Central Region Trustee in 2016, I had a very cloudy perception of the process of beginning service as a trustee. While I have been personal friends with every trustee in the West Central Region going back to the 1980's and have heard countless stories from these individuals, I do not recall one story of how a trustee really, practically begins their trustee service journey.

My telephone rang many times in the first days, and one of those calls included a "trustee buddy". Yes, the concept of sponsorship permeates AA from the top to the bottom of the service triangle and is part of even the General Service Board (GSB). However, things were pretty cloudy the first few months. I received communication of not only the three GSB Committees that I was assigned to serve on in my first year, but I also ended up on three subcommittees on the Public Information (PI) Committee before I even showed up for my first meeting. A bit overwhelming, even for someone that thought he knew how the GSB worked!

So, I showed up for my first GSB meeting in July of 2016 with a bit of apprehension of what I was supposed to do. With great fortune, the General Manager of the GSO was a friend from my delegate days and he took Susie and me out for supper on our arrival – whew, I could manage that! I didn't want to make any mistakes and wanted to do everything right. Fortunately, the first real meeting was a GSB Orientation. We had a nice warm-up sharing session where everyone introduced themselves, almost like an AA meeting, so that helped a bit. Soon, however, business began in earnest, and it hasn't let up since that morning in July of 2016.

The second orientation is a bit of a blur, but when the third one arrived, things changed. First, the Chair of the GSB made the decision to expand the orientation process – in my opinion, a very good decision, when you hear about the details, below. The second big change is this time, for a portion of the process, I was at the front of the room orienting rather than being oriented. Just like going from sponsee to sponsor, you sometimes wonder, "how did this happen?!" Of course, what a privilege to share with my fellow trustees on the GSB.

The expansion was in the scope of topics, a comprehensive binder of information, and quite notable, meetings in a sharing session format that catered to what we do best: share our experience, strength and hope. Of course, the expanded agenda necessitated more time, so we simply tacked on another day to the weekend when AAWS And AAGV were having their June Board meetings, thus making it as prudent as possible.

If memory serves me right, most of our discussions scheduled for 10-20 minutes per topic typically stretched closer to twice the time. However, I believe that was a good thing: people asked many questions, answers were provided in a collegial, welcoming manner and the orientation was successful in true AA fashion. While it is of greatest benefit to have this for the newcomers, topics such as "GSO and the General Service Board Working Together" or "How do the Affiliate Boards and the GSB Fit and Work Together" are likely also very valuable for the second year, even third year folks, especially for Class A's (non-alcoholic) who don't have experience on an affiliate board or in the service structure like Class B (alcoholic) trustees.

One topic unique to the service structure at the GSB level is fiduciary responsibility. With noted wisdom this topic was coupled into a topic titled "Satisfying the Spiritual and Legal Requirements That Guide Our Actions". This topic is well-defined in several sources. First, I want to recognize the Conference Charter. While not a legal document but rather termed a "spiritual contract" by Bill Wilson, without a full understanding and application of this spiritual contract with the fellowship, I believe our conference process and structure would not exist today – indeed, AA may not have endured for 84 years without this to help us be humble and obedient servants to one another in unity, animating the Fifth Tradition. So, priceless while not legal in the conventional sense. (Continued pg. 4)

## Trustee Orientation Preparation for Service

The orientation also references the core legal document, the Bylaws of the General Service Board of Alcoholics Anonymous, Inc. You can find this legal collection of directives the GSB must adhere to in Appendix E of the Service Manual. Notable in the Bylaws is very specific language related to our Steps, Traditions and Concepts. While out of the scope of this article and not part of the orientation, let me excerpt some highlights from the Bylaws on these specific items to appreciate what an orientation can accomplish:

**Steps:** "The General Service Board of Alcoholics Anonymous (hereinafter referred to as either the "General Service Board" or the "Board") claims no proprietary right in the recovery program, for these Twelve Steps, as all spiritual truths, may now be regarded as available to all mankind. However, because these Twelve Steps have proven to constitute an effective spiritual basis for life which, if followed, arrests the disease of alcoholism, the General Service Board asserts the negative right of preventing, so far as it may be within its power so to do, any modification, alteration, or extension of these Twelve Steps, except at the instance of the Fellowship of Alcoholics Anonymous in keeping with the Charter of the General Service Conference of Alcoholics Anonymous as the same may from time to time be amended (hereinafter referred to as the "Charter")."

**Traditions:** "The General Service Board shall use its best efforts to insure that these Twelve Traditions are maintained, for it is regarded by the Fellowship of Alcoholics Anonymous as the custodian of these Traditions and, accordingly, it shall not itself nor, so far as it is within its power so to do, permit others to modify, alter, or amplify these Traditions, except in keeping with the provisions of the Charter."

**Concepts:** The General Service Board also shall be guided by the spirit of the Twelve Concepts of Alcoholics Anonymous, hereinafter referred to as the "Concepts"....

>>Let me note a link in Concept XII to the Charter, as stated in the Concept: "The Warranties of Article 12 [of the Charter] are a series of solemn undertakings which guarantee that the Conference itself will conform to A.A.'s Twelve Traditions..."

Note the reference to the Charter in all cases?!

As would be typical of a non-profit corporation, the GSB has a Certificate of Incorporation. But unlike a typical not-for-profit, the GSB is to function in a servant-leadership fashion. Hence, the orientation provides an explanation on how that is accomplished, along with an array of documentation to support that operating philosophy.

Other topics on fiduciary responsibility ranged from maintaining our copyrights, preserving the integrity of our name, sound auditing practices, an understanding of the comprehensive financial controls and reporting AA utilizes, and of course, our Tradition of self-support. By the time the orientation was complete, a vivid awareness of our Seventh Tradition was felt by everyone.

This year an orientation committee continues to perfect and enlarge the orientation process. Using resources, primarily trustees that have had several years of experience, the GSB orientation continues to improve, responding to changing conditions in AA as well as the outside world, while still insuring the basis of our core principles found in the Twelve Traditions are steadfastly maintained. By such actions as a thorough orientation, Board members can be of maximum service to God and the fellowship of AA.
