Step 4

"Made a searching and Fearless Inventory"

I remember feeling afraid as a kid and thinking that I was a coward--that the mere presence of fear in my life made me a coward. I did not know that one of the definitions of courage was the ability to do the right thing in spite of fear. One particular word in the Fourth Step that I had difficulty with, therefore, was the word "fearless." "Fearless" does not necessarily imply the absence of fear. Fearless means "with courage."

What stops many of us from doing the Fourth Step is fear and pride, and that is certainly what stopped me. In addition, I wanted to be sure I did it perfectly. I didn't know that perfectionism is a character defect; it is in itself an imperfection.

I believe that if I had not tackled the inventory when I did, the guilt could very likely have killed me; and it wouldn't have been God who was punishing me either. I would have done the job myself. We are not punished for our sins, we are punished by our sins. of my sponsor I saw that I had uncovered a lot of fear and resentment. I believe that resentment destroys cells within my body. I learned in a biology class that body cells are constantly dying off and being replenished. What the class did not teach was that under negative conditions such as fear, anger, jealousy, hatred, and resentment the cells die at a much more rapid rate than when we are feeling love.

My Fourth Step also showed me that I had an acid tongue--committing murder by character assassination. In my recovery I am sometimes able to pause before speaking long enough to ask three questions: "Is it true?" "Is it kind?" "Is it necessary?" I could reduce all three to one question: "Before I say it--would I want it said to me?"

Prior to the Steps I had isolated myself from God and man. People are lonely because they build walls instead of bridges.

Many, many times while jogging I have repeated over and over, "I am beautiful, capable, and lovable." I needed this repetition in order to improve my self-image.

# **Tradition 4**

# Each group should be autonomous except in matters affecting other groups or A.A. as a whole.

When a group treasurer discovered a financial predicament, the members stepped up with a plan

A while back, our group's treasurer passed away and the status of our group's finances was unknown. The first order of business after his death was to audit our group's account. Contributions to GSO, our area and district, and to our Central Office. We were also able to buy new books for our book studies. Other groups in town took notice. One group even put out a special can for coffee contributions, telling its

The audit revealed that the Seventh Tradition basket contributions were not covering the group's expenses. Turns out, our former treasurer had been keeping our group afloat with his own out-of-pocket contributions. Without his contributions, our group's bank balance now began to rapidly decrease. Contributions to AA service entities were immediately stopped.

Our group's three-year lease on our meeting space was soon coming to an end. As the new treasurer, I wasn't willing to sign a three-year lease. Our bank balance was decreasing at a rate that would zero-out in about nine months. So I negotiated a six-month lease in the interim. We now have a month-to-month lease.

We found that the biggest drain to our expenses was coffee, coffee creamer and sugar. Also, meeting attendance was declining, mostly because of the disruption caused by those who were coming into our meetings looking only for a restroom or a free cup of coffee.

At our monthly business meeting, the group decided to stop serving coffee. Shortly after that business meeting, the rumor spread around town, via social media, that our group had closed its doors. There is an old saying that goes: A lie can travel halfway around the world before the truth can put its socks on. This misinformation about our group lingers still today.

A few weeks later, our group decided to resume serving coffee, but also decided that we would no longer buy coffee, sugar or coffee creamer. Group members were free to contribute these items on their own. The group would continue to buy coffee cups and other group supplies.

Fortunately, our group's financial situation began to turn around. Membership slowly increased. Coffee and coffee supplies continued to be available through voluntary contributions. The group was able to resume making monthly contributions to GSO, our area and district, and to our Central Office. We were also able to buy new books for our book studies. Other groups in town took notice. One group even put out a special can for coffee contributions, telling its members that the group's Seventh Tradition basket contributions would not be used for coffee expenses.

Other groups around town are beginning to realize that coffee expenses are keeping them from supporting GSO and other AA service entities. Many members now bring their own coffee or bottled water to meetings.

The Fourth Tradition cautions against doing things that would harm other groups or AA as a whole. Wasteful use of Seventh Tradition funds could be considered harm to other groups or AA as a whole, if such waste means that local, area and world services are not financially supported.

It's been nearly two years since our group took what was considered drastic and unheard of action regarding coffee at our meetings. I am happy to report that our meeting attendance has increased and we've maintained a healthy checking account balance. It's our wish that our experience will inspire other groups to look at their overall expenses and decide if they can find new ways to support AA and help carry the message of AA to those who have yet to find their way to our doors.

### THOUGHTS FROM THE BOARD

### **Sponsorship**

When I first started AA, I was filled with uncertainty and fear. I had no idea how to proceed through these 12 steps that everyone said were so important and I really struggled to build connections with others. I was introduced to the concept of having a sponsor. It took me some time to find the right person and I've had several sponsors along the way. Each one has helped me on the path to recovery. I was reminded that others have gone through the same feelings and experiences that I have. As I suffer from Terminal Uniqueness (the idea that no one else can understand everything I've gone through), this has been a necessary and humbling experience.

Having a sponsor has allowed me a path through recovery. For me, recovery is more than not drinking. In recovery I have become increasingly comfortable with myself and my place in the world. My sponsors have provided personalized support that I've needed. When I've faced moments of temptation and self-doubt, knowing that I could reach out to someone who has faced similar struggles was incredibly comforting and necessary. My sponsors have helped me work the 12 steps, offering insights and wisdom making the process less overwhelming. I've felt guided every step of the way.

My sponsors have also served as role models for me. Watching someone maintain their sobriety through the ups and downs has instilled a sense of hope for me. My sponsors' journeys showed me that the road to recovery is not a solitary path, but one that should be travelled with support and camaraderie. It is a reminder that the opposite of addiction is not sobriety but connection.

We need to have connections with others to maintain our recovery journeys.

Being a sponsor has also been a profound experience for me. It has been another reminder that I am not alone in my experiences and feelings. Guiding someone else through the steps has not only reinforced my own commitment to sobriety but has also deepened my understanding of the struggles we face. It is a humbling experience to share my story, listen to another's, and celebrate their victories. Sponsorship has created a sense of community and taught me ways to engage in deeper connections with others.

Being a part of the sponsor-sponsee relationship is mutually beneficial. While I have gained support and guidance, I have also experienced personal growth and strengthened a commitment to my own recovery by being a sponsor. This has enriched my understanding of community and the importance of supporting one another in our journeys. It is important to remember that the first word of the first step is "We". No one can recover alone.

The committee meets every 2nd Thursday of the month at 5pm via zoom to talk about plans of action.
